OFFICE MEMORANDUM

In reference to the cabinet decision no 2187, an office memorandum No. 25(III)/DGEHS/140/DHS/2011/11716-990 dated 17/08/2015 was issued whereby the need of authorization / referral for entitled treatment for self and dependent family members in private recognized hospitals was done away irrespective of grade pay, however, no separate directions were issued for availing dental treatment which is presently available only after an advice by Govt. dental specialist.

In this regard, a number of representations have been received from the beneficiaries requesting this directorate to do away with the condition of obtaining prior advice/referral of a Govt. dental specialist as has been done for other entitled treatment vide OM dated 17/08/2015, due to difficulties in getting such advice for obtaining dental treatment. In consideration to the request, it has been decided to allow dental treatment in private empanelled dental centers and hospitals empanelled for dental facility without referral/advice for the procedures enlisted in the CGHS/DGEHS list.
