OPTIONS UNDER FR 22(1)(A)(1):

OPTION 1: Pay Fixation from the date of grant of MACP/Promotion

OPTION 2: Pay Fixation from the date of Next Increment

IMPORTANT:

- 1) If any employee does not submit any option, then OPTION 1 is automatically applicable.
- 2) If any employee wants to choose OPTION 2, he/she must have to submit his/her option in written duly countersigned by the Head of Office and entered in Diary Register.

IMPORTANT:

- Option Form must be submitted within 1 Month from the date of issue of MACP/Promotion Order.
- 4) Option once submitted, cannot be changed in future.
- In case of Ad-hoc Promotion, Any option under FR-22 is not available.
 These options are available only after regular promotion.

Pay Fixation Procedure

OPTION 1: Fixation from the date of MACP/Promotion

 One Notional Increment will be added to existing Basic Pay as on day of MACP/Promotion in the existing Level.

 He/she shall be placed, at a Cell equal to the figure so arrived in point 1, in the Level of MACP/Promotion. If no such Cell is available in the Level of MACP/Promotion, he/she shall be placed at the next higher Cell of that Level.

OPTION 2: Fixation from the date of date of Next Increment

 From the Date of MACP/Promotion to the Date of Next Annual Increment, Basic Pay will be fixed in Next higher Cell in the Level of MACP/Promotion.

On the Date of Next Increment, Basic Pay will be re-fixed by adding
 increments (first due to annual increment and second due to MACP/Promotion) in the Level from which the Govt. servant got MACP/Promotion.

3. Then he/she shall be placed, at a Cell equal to the figure so arrived in point 2, in the Level of MACP/Promotion. If no such Cell is available in the Level of MACP/Promotion, he/she shall be placed at the **next higher Cell** of that Level.

Date of Next Increment

- The First Increment in the Level of MACP/Promotion shall accrue on the following 1st July or 1st January, as the case may be, provided a period of <u>6 months</u> qualifying service is strictly fulfilled.
- 2. The Next Increment thereafter shall accrue only after completion of ONE year.

Which Option is better

Option 2 is beneficial in most of the cases.

However, Option 1 is better in following cases:

- 1. Date of MACP/Promotion falls on Date of Annual Increment.
- 2. Minimum Basic Pay of Level of MACP/Promotion is higher than the existing Basic + 2 increments in existing Level.
- 3. Date of Retirement is prior to Date of Next Increment.



Example 1: MACP/Promotion in Levels having different figures

- MACP is granted from Level 4 to Level 5 w.e.f. 10 Apr 2020
- Existing Basic Pay in Level 4 is 30,500
- Date of Next Increment is 1st July 2020

- MACP is granted from Level 5 to Level 6 w.e.f. 01 Jul 2020
- Existing Basic Pay in Level 5 is 40,400
- Date of Increment is 1st July 2020

- Promotion from Level 4 to Level 6 w.e.f. 12 May 2020
- Existing Basic Pay in Level 4 is 30,500
- Date of Next Increment is 1st July 2020
